The installation of KKMC LCEC members will be held on Sunday, 10 October 2021, at the 10am Devotional Worship Service.

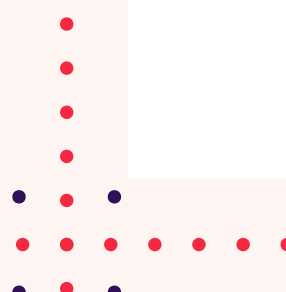
What does the LCEC do?
